NOMINATION OF PRESIDENTIAL AND PARLIAMENTARY CANDIDATES FOR THE CONDUCT OF THE 7TH MARCH, 2018 ELECTIONS.

In exercise of the powers conferred on it by Section 33 of the Constitution of Sierra Leone, 1991(Act No. 6 of 1991); and pursuant to provisions of Section 39 of the said Constitution and Sections 69 and 70 of the Public Elections Act, 2012 (Act No. 4 of 2012), the National Electoral Commission (NEC) makes the following proclamation:

1. **Wednesday, 17th to Friday 26th January, 2018** is the period for Nominations of Candidates for the conduct of Presidential and Parliamentary Elections for the 7th March, 2018 Elections.
2. The deadline for Political Parties to submit the List of Endorsed Candidates for the said Nominations to the National Electoral Commission (NEC), in accordance with **Sections 61 and 62 of the Public Elections Act, 2012**, is **Wednesday 10th January, 2018**.
3. The place of nomination for Presidential candidates is the NEC Headquarter, O.A.U Drive, Tower Hill, Freetown.
4. The nomination centres for Ordinary Member of Parliament candidates are as follows:

5. Eligible Sierra Leoneans may also contest as Independent candidates for Ordinary Members of Parliament Elections (but not for the office of Presidency).
6. Qualifications and disqualifications for Presidential candidates are found in **Sections 41, 75 and 76 of the Constitution of Sierra Leone, 1991 (Act No. 6 of 1991)** and **Sections 44, 45 and 46 of the Public Elections Act of 2012.**

7. Qualifications and disqualifications for Ordinary Member of Parliament Candidates are found in **Sections 75 and 76 of the Constitution of Sierra Leone, 1991 (Act No. 6 of 1991)**.
8. Pursuant to Statutory Instrument No. 13 of 2012, the candidates's nomination fee for the Presidential Election is **ONE HUNDRED MILLION LEONES (Le.100,000,000.00) per candidate, payable to the National Returning Officer;** and **TEN MILLION LEONES (Le.10,000,000.00)** for Parliamentary Election per candidate, payable to the District Returning Officer in the respective districts.
9. Other details for the Nominations of candidates and conduct of the election shall be published by the National Electoral Commission in due course, if omitted.
